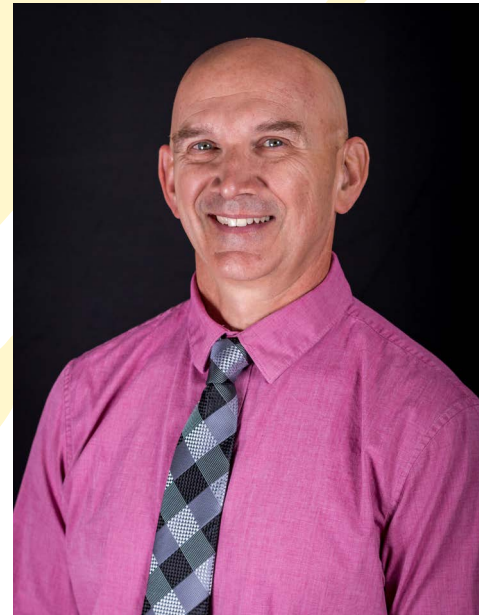
Was it easy? No. Was it worth it? Absolutely! About 100 people, both children and adults, got the camping experience that they desired, despite the challenges that were present.

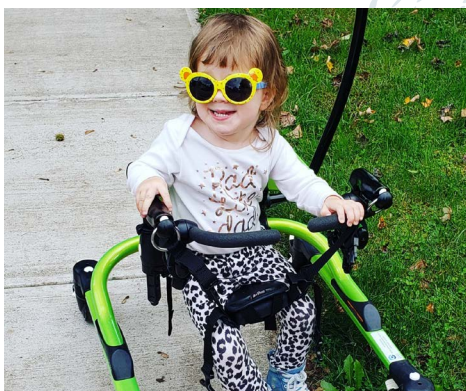

Amanda Gransky has been utilizing the Early Intervention program since June 2020 for her daughter Madison.



“The experience has been amazing,” says Amanda. “Madison, who was diagnosed with Cerebral Palsy, has progressed by leaps and bounds.”

Madison receives in-person services for Occupational Therapy and Physical Therapy. As a result, she is much more mobile than she was in the beginning of the process and is working on walking.

“I am very thankful for my daughter’s

progression and for the excellent care that she has received from her therapists,” says Amanda. “When we moved from Hawaii to Belvidere a year and a half ago, I immediately reached out to The Arc of Warren County for support and she has been in good hands ever since.”

## An Arc of Warren County Employee Highlight --- Andrew Cuenco

It was a family tradition to work at The Arc of Warren County for Andrew Cuenco. His mother was a manager for many years and retired recently. According to Andrew, he always had a gravitational pull toward the population that The Arc serves. In 2007, Andrew served as a DSP at the Asbury Group Home and is now a Relief Manager.

“It is no secret that this isn’t the most lucrative profession,” says Andrew. “Making people’s lives better as a result of my commitment provides me with rewards.”

For Andrew, he is motivated by helping the residents learn new skills and grow in their ability to make decisions for themselves. He feels more so this way with consumers who are non-verbal.

“Seeing the smiles on their faces and how gracious they are provides me with much fulfillment,” says Andrew.

During the lockdown, Arc employees had to get creative in their homes on how to engage consumers in a safe manner. Some of the activities that helped get everyone through this time included engaging consumers in yard games, wiffle ball, volleyball, arts and crafts, spending time on the patio and engaging in puzzles and workbooks.

“Some of our staff do 12 to 14 hour shifts and there needs to be enough to do to keep our consumers involved,” says Andrew.

When asked what suggestions he might have for new employees who work with consumers, Andrew says that it is important to have patience, human empathy and have a resilient mindset.

Andrew says that he always urges his staff and new managers to “just remember why we are here.”

“I always stress to my team that it is easy to get caught up with your own lives, but this position requires the best of us,” says Andrew. “I tell new managers sometimes you are not walking into ideal scenarios. It is important to not come to work stressed. Leave your own personal issues at the door. Rely on each other. Everyone has the same goal.”

If you are not open to being a problem solver, this career will be even more challenging for you, according to Andrew.

“We are our consumers’ families,” says Andrew. “They depend on us every day.”

After seven years as a manager, Andrew finds it to be essential to establish a rapport with new employees. It is important to support staff, especially when they go through their own ups and downs in life.

Andrew credits his mother for encouraging him to get into this field and says that his own manager – Eleanor Nero – showed him how being kind and being firm could be done with grace. His supervisor, Kayla Conklin, has supported his tenure as the manager and his philosophy on how a manager should support their staff. His fiancée, The Arc of Warren County Nursing Supervisor Kim Southard, helps keep him focused and motivated, and has supported him through the ups and downs of working through a pandemic.

“My staff at the Asbury group home deserve to be credited for their resiliency and hard work through this pandemic and beyond,” says Andrew. “They are amazing and I am so fortunate to work with them. They are Paul Kaspereen, Relief Manager (now Program Manager), Chris Bauknight, Senior DSP and DSPs Derrick Thompson, Cyle Connors, as well as Overnight Awake DSP Cameron Martin.”

## In Remembrance of Gail Geene

Part of this article was created based on information from her sister, Jill Notte, who wrote her words of remembrance for Gail's funeral service. Jill remains very active as part of The Arc of Warren County community.

Gail Frances Geene, a 25-year resident of The Arc of Warren County's Hampton Terrace Group Home, passed away on June 15, 2021. Gail was an integral part of The Arc family and left a positive impact on those who had the honor of knowing her.

Gail was born with a rare genetic disorder called Prader-Willi Syndrome (PWS), named for Swiss doctors, Andrea Prader and Heinrich Willi, who first described it in 1956. PWS is caused by a deletion in the 15th chromosome and is characterized by learning disabilities, an insatiable appetite, weak muscle tone, and a slow metabolism. Without interventions, the combination leads to rapid weight gain.

According to Gail's sister Jill, if anyone were up to the challenge of raising a special needs child, it was their mother. She faced all of Gail's developmental delays with patience and determination. She assured doubting family members that Gail just needed extra time to walk - which she did at age 3!

Gail's learning disabilities became apparent when she started school. She repeated kindergarten, then repeated first grade before she was assigned to special-needs classes.

Gail was blessed to have several teachers in her early education that spent extra time to teach her to read. This made a huge difference in her life, as she loved books and going to the library at every stage of her life.

Today, babies born with PWS can be diagnosed within weeks with DNA testing, according to Jill; but Gail didn't receive a proper medical diagnosis until she was 18, when the rare disorder had finally made it into US medical books and was highlighted by their grandmother's general practitioner in the late 1970s. By this point, Gail had developed diabetes as a result of her extreme weight gain.

After Gail's diagnosis, their parents joined a local support group, met other parents of children with PWS, and eventually got her enrolled in a specialized program at The Children's Institute in Pittsburgh. This program

helped Gail lose weight and helped her parents continue the journey through special food preparation and other interventions. But Gail and Jill's parents wanted to ensure that Gail's future was secure as they approached their late 70s.

"They learned that a new group home known as "Hampton Terrace" had been established by The Arc of Warren County," says Jill. "It was in Phillipsburg, about an hour from their home, and it was specifically developed to meet the needs of PWS women. It took some time, but a room opened up and Gail was approved to take it."

Gail continued to lose weight at Hampton Terrace and eventually reached her goal weight after losing a total of more than 100 pounds. She reversed her diabetes and eliminated the need for insulin injections. She was

able to do her favorite activities with much more ease, including walking, biking, bowling, swimming, and dancing.

Jill credits The Arc of Warren County for the impeccable care that her sister received.

"I consider the direct care staff and behaviorists in the program to be some of the top experts in the world in understanding people with PWS and how to help them be happy, healthy and successful," says Jill. "They are constantly evaluating solutions, partnering with researchers at the Vanderbilt-Kennedy Center in Nashville and learning from hands-on experience, 24/7. In fact, Gail, her housemates and The Arc staff had a couple of fun and productive trips to Vanderbilt to participate in a research study."

According to Jill, The Arc community was Gail's family.

"They knew her and cared for her like she was their sister or mother," says Jill. "She was even Grandma Gail to the staff's young children and she was often invited to their homes to visit with their dogs. They traveled with Gail to bring her to our family weddings, showers and funerals. They helped me plan Gail's surprise 60th birthday party and showed up in big numbers to make the party a blast. As her mobility declined, they remodeled the house to accommodate her needs so that she could live there as long as possible. Gail and my whole family have been blessed beyond measure to have The Arc in our lives."

Shana Frondorf, Board Certified Behavior Analyst of The Arc of Warren County, recalls many of her favorite memories with Gail. One of them includes their road trip eight years ago to The Children's Institute in Pittsburgh. They had a lot of fun singing to different songs during that car ride.

"This is a moment that will forever be with me," says Shana.

Shana was also with Gail on a trip to Point Pleasant to enjoy the beach, walk the boardwalk and visit the aquarium.

"She was so happy," says Shana. "I recall her squealing with glee when she experienced the touch tanks. It was pure joy."

Shana also fondly remembers attending her 60th birthday and how pleased Gail's family was to learn that Shana's sons referred to her as "Grandma Gail."

"She beat the odds," says Shana. "She outlived the life expectancy for someone who has PWS."

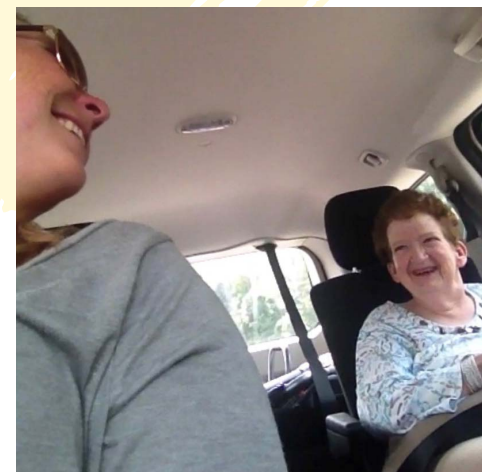
Elizabeth Roof, Senior Research Specialist and Research Lab Director from Prader-Willi Syndrome Initiatives at Vanderbilt University also shared her sentiments on their Facebook page after Gail's passing:

"It makes me feel so lucky to have known her. Her participation in our studies over the years has highlighted aging in PWS and helped develop drugs that will help others with PWS. Her life had great meaning

for those who knew her and for those with PWS who will benefit from her efforts and sacrifice. I hope that she is happy, full and has a house full of puppies nipping at her heels and a handsome boyfriend who is feeding her all the food she loves. Gail, you are one in a million. Gail, rest in the peace you so richly deserve."

Gail's last 14 months here were full of challenges and uncertainty. She suffered a heart attack, a blood clot, two strokes, and seizure activity. She was in and out of six different hospitals and rehabilitation centers; yet she took it in stride and cherished the times in between when she was able to get back home to Hampton Terrace with the roommates and staff she loved. She finished her days on earth as a beloved patient at The House of the Good Shepherd and Ennoble Hospice Care.

Though Gail is not here in body, she will always live in the hearts of everyone who had the fortune of making her acquaintance.

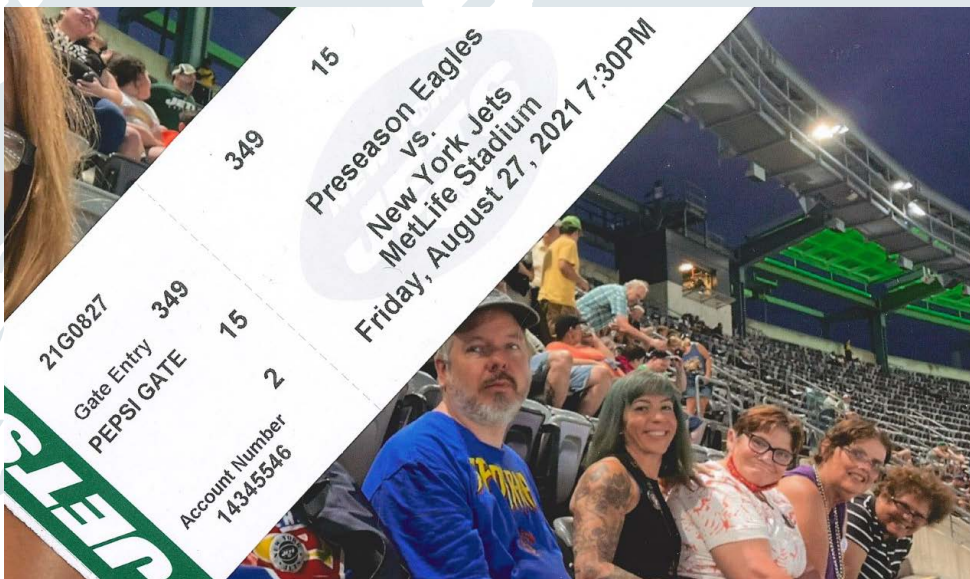
