## Letter from the CEO of The Arc of Warren County, John Whitehead

Everyone is aware of the staffing crisis that is going on in our nation today. Whether it be retail, manufacturing, healthcare, or the automotive industry, it seems that the shortage is at epidemic levels.

Unfortunately, we at The Arc of Warren County have not been spared from this issue. While we are blessed to have a very stable workforce in our administrative roles, our situation with our Direct Support Professionals (DSPs) is worse than it has ever been. Our current staff are doing amazing things and working more than ever to make sure that those we serve get the best programming possible. But how do we overcome this deficit in our workforce, especially when everyone else out there is competing for the same people? Why choose to work as a DSP as opposed to something else? Well, let me make my case.

I was a college student when I first started working as a DSP for The Arc of Warren County. The main reason I took the job is because it worked with my class schedule. Even though I have been in administration for over 30 years, those years working as a DSP have proven invaluable, and this

would be true even if my career had taken me elsewhere.

There is great value in caring for someone other than yourself. Working as a DSP requires that you be responsible, caring, and unselfish. It changes your perspective from “what’s in it for me” to “what can I do for you.” As a 21-year-old college student I will admit that this was not my natural attitude. But it didn’t take very long for me to see that the individuals that I was hired to care for were giving me much more than I could ever give them. They appreciated little things that I would dismiss. If they had a problem with me, they would let me know, right away. I call that honesty, which is a good thing. Maybe more than anything, they made me feel like I mattered.

I also felt privileged by the trust that they had in me. I found that being given so much trust that I hadn’t yet earned made me more determined to be worthy of it. The DSP role helped me to see that I could get more joy helping others than helping myself. This fact changed the rest of my life. It helped me be a better parent to my

three oldest children, and even more so when my fourth child, Adele, was born with Down Syndrome.

What I am trying to emphasize is we need DSPs to work in our group homes and supervised apartments.

If you or someone you know is looking for employment, contact us. We offer competitive pay, flexible schedules, and great benefits. In the end, however, the most important thing that we offer is a life-changing experience, whether you work for us for a year or as your career. It will be less about what you earn and more about what you’ll learn.

## *The John A. and Margaret Post Foundation Provides a Grant in the Amount of \$12,680 for a Generator*

The Administration at The Arc of Warren County is extremely thankful for a recent grant for \$12,680 that was earmarked for a generator for the White's Road group home. This is the fourth generator that was funded by The John A. and Margaret Post Foundation in recent years.

The Arc of Warren County was awarded grants for the cost of generators that were installed in the organization's group homes in

Belvidere, Alpha and Phillipsburg in 2019 and 2020.

"The continued support that The John A. and Margaret Post Foundation has provided has been extremely beneficial to The Arc of Warren County and those we serve," says John Whitehead. "In addition, many of our residents find it very frightening and disruptive when they need to relocate due to power loss, even if it is for a short period of time. These

generators make it possible for us to save on relocation expenses so we can spend our limited resources on other routine costs associated with operating residential programs."

The John A. and Margaret Post Foundation supports charitable organizations that benefit the quality of life for families and society in general with a primary focus on organizations in northwest New Jersey and northeast Pennsylvania.

The Arc of Warren County entered into an official Memorandum of Understanding (MOU) with the Domestic Abuse and Sexual Assault Crisis Center (DASACC) recently.

The purpose of this Memorandum of Understanding is to address the mutual goals and responsibilities regarding DASACC and The Arc of Warren County to strengthen communities by providing seamless service access for survivors with disabilities, a commitment to

strategic planning, increasing awareness about service availability, and creating opportunities that improve the lives of individuals with disabilities who have been affected by domestic violence and/or sexual assault. Part of the agreement includes committing to cross training between both organizations and assigning staff members to facilitate on-going communication between partner agencies.

## *The Arc of Warren County Employees of the Year = Jessica Squared! Jessica Chamberlin and Jessica Lewis*

### **Jessica Chamberlin**

Jessica Chamberlin knew at an early age that working with individuals with disabilities intrigued her. When she was nine years old, her mom encouraged her to do American sign language. As a result, she became fluent in sign language and had an interest in helping individuals who were hearing impaired. There were not a lot of opportunities to continue focusing on this career where she lived. She learned quickly that she also had an aptitude for helping individuals with intellectual and developmental disabilities when she became a personal caretaker. The girl, Hannah, that she cared for was legally blind, could not walk, was non-verbal and was in continuous seizure activity. Hannah loved listening to Andrea Bocelli. Jessica would have her listen to Bocelli to help get her out of seizure activity while pushing her in a swing. Although Jessica enjoyed

her time as her personal caretaker, the commute from Easton to Chester, New Jersey was taking a toll. After about a year, a friend from church told her that The Arc of Warren County was hiring.

Fast forward four and a half years later and Jessica feels like she is settled where she is supposed to be.

“I attribute it to learning American Sign Language at an early age and that interest has led me down this path today,” says Chamberlin.

The positions that Jessica has held include Direct Support Professional (DSP) for the Alpha Group Home, Relief Manager of Alpha and then Alpha Interim Manager before becoming Manager of the Hurley Group Home.

“This career offers a lot of

opportunities for growth,” says Chamberlin. When asked about job responsibilities, Jessica cites that all professionals who work with consumers should ask themselves how they can make the consumers succeed in their day, each and every day.

“Every day can include challenges, but it is important to make sure that each day is a positive experience,” she says. When asked about the challenges of working during Covid-19, Jessica says that she gives high recognition to all of the managers at all of the group homes.

“It is hard to explain,” she says. “Everyone has been through the wringer. It has been very challenging, but it feels good that there may be an end in sight.”

Jessica covers shifts at different group homes since the Agency has a staff shortages.

When asked about favorite memories, she talks about how she feels that every day they are creating important new memories.

She talked about Michael DiBiase, a consumer who recently passed away, that she was so blessed to have had him in her life. According to Jessica, he cared about people so much and was known for his silent laugh.

“When the consumers pass away or move on to a different facility, I reflect on the special moments that I had with them,” says Jessica.

In high school, Jessica felt a need to protect students with disabilities from bullying and keeps in touch with some of these former classmates.

She worked at The Arc of Hunterdon County, then came to The Arc of Warren County because it was closer to where she lives.

“I love it here,” says Jessica. “We take good care of our individuals. This is more than just a business. I can also just be myself here – playful, goofy and upbeat, and I’m appreciated for who I am.”

She just celebrated her nine-year anniversary with the Agency. She came on board as a DSP in 2013, was promoted to a Relief Manager and then to Program Manager. She is now our Quality Assurance Specialist in the Compliance Department at the office. In this position, Jessica works alongside Program Coordinators in the Community Living Arrangements and Community-Based Supports Departments to ensure that our Day

patience is important, as well as good morals and a solid work ethic. One should genuinely care for the consumers that he or she works with. She feels that it takes a special kind of person to work at The Arc. She gives credit to one of the Program Coordinators, Kayla Conklin, who mentored her and helped her to achieve the professional level which she has attained.

Programs, group homes and supervised apartments are maintaining operating standards. She also trains The Arc’s newest direct care staff in the online database that we use to document, Therap Services, as a Certified Therap Trainer.

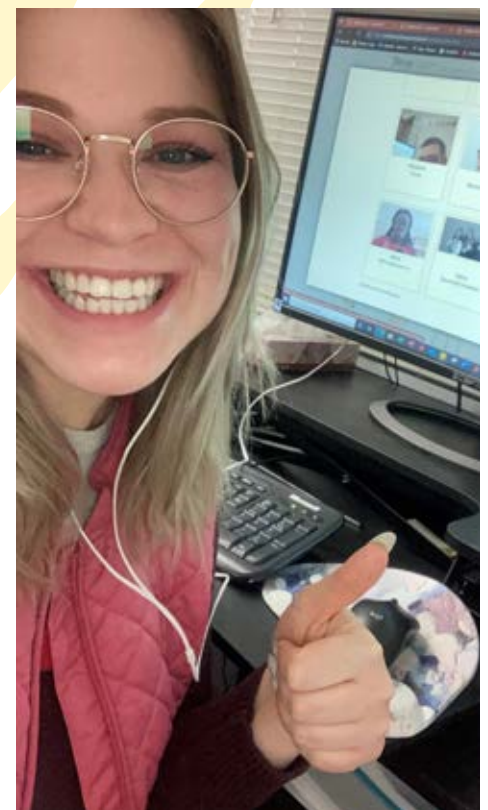
“I live to help people,” says Jessica. “Any time I can help someone I feel so honored. Our purpose at the Agency is to provide safety, support, and protection to our consumers. I am blessed to be able to do so.”

Jessica recalls being able to take several individuals home with her for Christmas, prior to the pandemic, and feeling lucky that she was able to have that experience. Her role models at the agency are Robyn Gardella, Assistant Director of Recreation and Kayla Conklin, CLA Coordinator. Robyn had been Jessica’s supervisor when she first became a Program Manager and she has fond memories.

“If I ever had a challenging situation and I wasn’t sure how to handle it,

## Arc Employee Highlight: Marcia Blake

Marcia has been an employee of The Arc of Warren County for 25 years. She wanted to work with individuals with disabilities as she has two family members with disabilities and felt that The Arc of Warren County was a good fit for her.

Her first position was working as a DSP at Hampton Terrace. She got a quick initiation, so to speak, when a consumer tied Marcia's sneaker laces together when she wasn't looking!

After Marcia's time at Hampton Terrace, she became an Individual Habilitation Plan Coordinator and then served as a DSP at Gardener Court.

Her current position is Community Living Advisor. It is a position that she has held for 15 years. She works in the Community Based Supports Department serving consumers who live independently with supportive services. Marcia works with 11 consumers in total. On a given day, she will work with two or three people. Her responsibilities include filling medicine boxes, taking consumers to doctors' appointments, checking their refrigerators, banking and food shopping, checking their refrigerators and putting food away.

"My favorite part of the position is not being in the office and being out and about," says Marcia. "I have the opportunity to go on fun excursions, like going to the Camden Aquarium and having picnics with the consumers at many local parks. I enjoy everyone's personalities and working with everyone that I do."

Some of Marcia's most memorable moments include working with Doris Meroni, a consumer who passed away. She brought her over to her home for Thanksgiving. Marcia has a favorite photo of Doris and Marcia's daughter.

"Consumers take a part of you when they go," she says. "The joy of working with individuals keeps me motivated, though sometimes it can be challenging."

Marcia's advice to be successful in her position or in any direct care position is that you need to love people and be willing to get your hands dirty. Colleagues who have inspired her include Carinne Buzzuto, Training Coordinator and Self-Advocate Adviser, who used to be Marcia's supervisor. In addition, past colleague Betty Burham inspired her because of her willingness to accept everyone for who they are.

"I love working here," says Marcia. "I like what The Arc stands for and working with consumers. I have made lifelong friends in my career here."

## In Memory of Pieter Woodcock

### *“This is the Hardest Job You Will Ever Love.”*

The Arc of Warren County lost a beloved member of the community recently – Pieter Woodcock.

The Woodcocks became involved with The Arc of Warren County when they found out that their son, Daniel, who is now 35 years old, was disabled. They had to find an Early Intervention program. Their first encounter with this organization was when they had a meeting at the Port Colden Manor, which was one of the former Administrative Offices for The Arc of Warren County.

Daniel didn't walk until he was four years old. Today he has a vocabulary of 70 words.

“Raising children is difficult in general but raising a child who is disabled has so many challenges that it is essential

to have support,” says Pieter's wife Karen.

As a result of the therapy that Daniel received from The Arc of Warren County, he made tremendous progress. “Some people are uncomfortable around individuals with intellectual and developmental disabilities, but the whole Agency was just so skilled at what they do,” says Karen.

Daniel went to Camp Warren until he was 21 years old. On Saturdays, he would attend the respite program. It would allow Pieter and Karen to go shopping and be able to attend events like baby or bridal showers.

Pieter was so impressed with the dedication and compassion of The Arc staff that he decided to join the Board

when he was asked and eventually became the President of the Board of Directors. He eventually needed to step down because of career responsibilities, as he was a senior sales representative in the pharmaceutical industry. When he retired, however, Karen and he made the decision for him to return back to The Arc of Warren County in a different capacity – Direct Support Professional (DSP). He was also on the HUD Board and the Community Living Arrangements Board Committee.

“It was a big decision financially and I had to take more hours in my professional role to make this happen,” says Karen. “Pieter found this career much more meaningful than his time in the pharmaceutical industry.”

According to Karen, Pieter was connected to the residents. He spoke to them like they were his own family members. He would bring residents home for the holidays. He would take them to doctors' appointments even as far away as Philadelphia.

He had a medical understanding of the challenges that the residents had to endure based on his experience with his own son.

“Pieter was always a pleasure,” says Robyn Gardella, Assistant Recreation Director, who was Pieter's supervisor from 2010 to 2017. “He would always say ‘I've retired, but am working here so I can provide for my boy.’”

Robyn claims that she misses his giggle and always remembers that he had a sweet tooth.

"He was the definition of a family man – taking care of Daniel and his grandbabies. He will never be forgotten."

Pieter also made a positive impact on his own community.

"Pieter, Karen and the kids lived next to us in Independence," says The Arc of Warren County donor, Connie Semler. "They were very nice people. We have very fond memories of Pieter. He was such a kind man."

On May 9, 2022, The Arc of Warren

County held a dedication in the memory of Pieter Woodcock. The Oxford Group Home, where he worked for 10 years, was renamed The Pieter Woodcock Group Home. Pieter is also being honored posthumously at The Arc of Warren County Awards Banquet on November 17, 2022 with The Lifetime Commitment Award.

"This is the hardest job you will ever love," said Pieter when he was interviewed for the 2017 Arc of Warren County video when he was asked about his job.

"Pieter was such a loved member of The Arc of Warren County community," says Leslie Schott,

President of the Board of Directors. "I am so pleased that we could recognize him in this manner."

## The Arc of Warren County Connection = A Strong Bond

“If it wasn’t for The Arc, I don’t know what would have happened to me or Rosemarie,” says Jane Pagano.

“They know her so well.” Jane’s sister Rosemarie is a resident of one of The Arc’s 17 residential programs in Warren County.

Jane recalls Rosemarie’s early days when she was a child. It was after kindergarten when she was diagnosed with an intellectual disability. Jane wishes that Early Intervention programs were available back then. Today, IDD is respected, but back in the 1960s some people were less than accepting and kind towards people with disabilities. Name calling was common.

Rosemarie lived with her parents until their mother could not care for her any longer due to her own health issues. She lived with Jane for 18 months before she came to live at The Arc. Jane had alternating respite weekends between Rosemarie’s sister Kathy and brother, George.

“I couldn’t just send her any place,” says Jane. “It had to be the right fit.” They were living in Bergen County and received calls for Rosemarie to be placed in other areas of the State.

They were not in areas that appealed to Jane, nor were they conveniently located to her siblings. When she was invited to visit Oxford, however, Jane was impressed that it was located on four acres of property and in the beautiful county of Warren. When they arrived, Rosemarie was greeted by a fellow housemate who hugged her and showed Rosemarie her room.

It was a great fit and Jane felt so pleased that Rosemarie found a happy home.

Jane now lives in North Carolina and rests easy that Rosemarie is cared for and is having fun. She became well-adjusted and more independent. She visits Jane, and Kathy, and her nieces four times per year in North Carolina, and also her brother, George, in Sussex County, NJ.

She never needs a suitcase when visiting. Jane keeps a seasonal wardrobe on hand to make her air travel simple. “Rosemarie can’t stay more than five nights,” says Jane. “She wants to go home. She is concerned about what she is missing and looks forward to going back ‘home’.”

Jane recalls a recent trip that Rosemarie had when she went to North Carolina. She received feedback from some of the passengers, while she was waiting for Rosemarie to come off the plane. The undivided attention and care that Amber Martinez, the Manager at the Oxford Group Home, showed toward Rosemarie while at the gate awaiting her flight, was commended by the other passengers and airline staff. One passenger said that they thought Amber was a family member caring for her loved one!

When interviewed for this story, it was evident that Amber and Rosemarie have a strong bond and wonderful chemistry together. They finish each other’s sentences and Rosemarie seems quite connected to her.

“I have a lot of fun living here,” says Rosemarie. “I am really happy.” And so is her family!

“I am so very grateful that I can count on Amber and other staff members for the wonderful care my sister receives,” says Jane. “Being here in NC, it is a relief to know she is happy and has been for more than 10 years.”
