Letter from the CEO of The Arc of Warren County, John Whitehead

A busy summer is winding down at The Arc of Warren County and a very busy fall season is underway. Throughout the agency big changes are coming that will help us to improve and enhance the services that we provide.

Camp Warren completed another successful camp season that provided great memories for all who attended. The camp has had extensive renovations over the past few years and is looking great. We have more upgrades planned for next year and welcome everyone to come out and take a look!

After purchasing the site of our former "respite" group home, we are near completion of the future Jonestown Road Group Home. We have taken great measures to ensure that this house will be a welcoming and safe home for the new residents.

This home has been designed to accommodate all the needs of the new residents in a beautiful setting. It has dual HVAC systems and a whole house generator, a large rear deck with a ramp for accessibility, and a completely new interior (new kitchen, baths, walls, flooring...

you name it, it's new). We anticipate opening this site soon.

Simultaneously, we are in the process of renovating a leased space that will be the new site of our Washington Day Programs. This will be located at the junction of Route 31 and Asbury-Anderson Road in Washington Township. At 4,000 square feet, this site is double the size of our current day program space. We will go from two small rooms to seven separate dedicated spaces including a horticulture area; a "living room" area with couches and recliners for when someone needs a rest (and will be the home of our fish tank(s)); a craft area with several tables, a large area for stationary bikes, a piano, and music therapy; a large kitchen; a lunch room; a sensory room; and a woodshop/tool storage area. This will make it possible to serve more individuals for day services as well as offer a large enough site for our Recreation department to hold dances, social club, and other activities. It is our hope that this new site will be opening in the fall.

We are very excited for the growth that we are experiencing because it

gives us the opportunity to do more for those in Warren County who enjoy and rely on our services. I regularly interact with my coworkers in all departments – Office Administration, Early Intervention, Community Based Supports, Recreation, Community Living Arrangements, Day Services, Development and Communications – and I see how they continue to go above and beyond to help us to achieve our Mission. It's great to be part of an organization that is thriving in the present with an eye on the future!

It is with gratitude that I write to you today. Thank you to all of you who support The Arc of Warren County whether you have done so once or continue to do so on a regular basis.

As our 70th anniversary is right around the corner, it is a wonderful opportunity to reflect on the many accomplishments that the organization has achieved. We continue to serve 1.100 individuals with intellectual and developmental disabilities and their families. We have come a long way since we opened our first group home back in 1982. We now have 17 residential programs throughout the county and have one that is currently undergoing a complete transformation. The Arc of Warren County is one of the few Arc Chapters that has an Early Intervention program. Our summer camp program at Camp Warren in Knowlton

Township continues to provide wonderful opportunities for ndividuals to participate in fun activities at a beautiful venue and provides respite for parents. Our community-based supports program provides individuals with support to be able to thrive independently. Our Day Programs are growing, and our office space will be expanding as a result as our CEO, John Whithead, highlighted in his letter.

Some funds raised this year have made projects possible such as major renovations to Camp Warren, camperships and some renovations to our Jonestown Group Home.

Employee Highlight - Meet Reni Piperata, LPN.

Sometimes an opportunity presents itself and at that time you don't think it is the ideal opportunity for you, but you try it anyway. It is possible that you can be pleasantly surprised and find your calling in the process. This is the case with Reni Piperata who is a Licensed Practical Nurse for The Arc of Warren County.

Reni was no stranger to hard work at a young age. At 15 years old, he washed dishes in a restaurant. This was the start of many years working in the hospitality industry. He disliked this job and worked one week before quitting. He stayed without a part-time job for a bit until his grandmother urged him to find a new position. His dad told him about a job at Harker's Hollow Golf Club and he started there as a dishwasher again. This time though he was quickly working in other capacities, such as preparing food and slicing meat. He then became a short order cook. He was pleased when they offered him a position outside of the kitchen, bussing and waiting tables and then ultimately bartending. He liked serving as a bartender. It was a fun, fast paced position with a lot of networking opportunities.

He decided, however, to pursue his degree in Speech Communication at Northern Kentucky University and left New Jersey for a while. During his time in Kentucky, he worked at The Hilton in Cincinnati and at a country club in Fort Mitchell, Kentucky. He decided to come back to New Jersey eventually and worked at Harker's Hollow Golf Club once again. He then worked in the finance industry for one year as a mortgage salesman. In 2008, the economy took a downward turn, and nobody was doing loans. He worked

on commission and needed a steady paycheck.

His friend, who was a longtime employee of The Arc of Warren County, suggested that he fill out an application for a Direct Support Professional position.

"It wasn't the career path that I considered before this," says Reni.
"I decided I would accept the position and just plan to stay a year."

Reni quickly became promoted to a Manager and held other positions, such as part-time Crisis Management Trainer and taught other safety trainings upon request.

"It was fulfilling work, but after 10 years I felt that I wanted an opportunity to secure a higher salary," says Reni. After being with a resident who passed away during her final moments, Reni felt a calling to become a hospice nurse.

He enrolled in the Warren Tech Licensed Practical Nurse (LPN) Program, which was operated out of Warren County Community College's Phillipsburg location. It was a program that took him eleven months to complete. After he completed his LPN, however, he felt that working in a hospital or senior living facility did not appeal to him. He really wanted to stay with The Arc of Warren County and was pleased when the position of a Licensed Practical Nurse opened.

He has held this position for three and a half years and assists in nursing care for approximately 70 residents. Reni likes the diversity of his current position as every day is very different. Staff education is a significant part of his responsibilities. For example, he teaches staff how to take blood glucose, monitor blood pressure and vital signs and he provides various safety education classes for them.

When asked which staff members have inspired him through the years, he credits Kim Southard, Nursing Supervisor, for teaching him so much about the profession and Robyn Gardella, Assistant Director of Recreation, for her professional insight and her staunch commitment to the organization.

The Arc of Warren County community is fortunate to have Reni on our team. Thank you, Reni, for everything that you do!

Autism Advocate Dr. Kerry Magro on Anti-Bullying

Autism advocate and internationally renowned speaker Dr. Kerry Magro presented "I Used to Be Bullied for Having Autism: Here's When It Stopped," at Warren Hills Regional High School in May. Dr. Magro's talk offered a first-hand account of a young man who was bullied as he was growing up on the autism spectrum. He shared the difficulties of having autism and not being able to express and defend himself. Dr. Magro discussed the causes and effects of bullying on our community and in our schools, including a powerful story of a young woman with autism and the struggles she faced while reconciling with her self-worth in the aftermath of bullying. He also touched on behaviors that are considered bullying, including cyberbullying, and the damaging effects it can have on students. Dr. Magro detailed a seven-step plan to take a stand against bullying that self-advocates, families, and professionals can adopt.

Dr. Kerry Magro Ed.D. is an award-winning autistic professional

speaker, bestselling author, and autism consultant to the HBO series "Mrs. Fletcher" that aired in Fall 2019 and the latest season of Netflix's Emmy Award-winning series "Love on the Spectrum." He started professionally speaking in 2011 via the National Speakers Association after he fell in love with theater as a child to help with his social and communication skills. Today, he has spoken at over 1,200 events, including two TEDxTalks and a "Talks at Google" presentation.

We are fortunate to have the opportunity to bring thought leaders like Dr. Magro to our community. Dr. Kerry Magro's presentation was made possible through a collaboration with event sponsors Greenwich Autism Alliance Foundation, The Arc of Warren County, Abilities of Northwest Jersey, Inc., and Warren Hills Regional High School. Embracing Diversity: The Story of Disability Pride Month

Disability Pride Month is celebrated each year in July and is an opportunity to recognize the achievements, struggles, and contributions of people with disabilities. Historically, society has marginalized and stigmatized people with disabilities leading to unequal treatment, limited accessibility, and systemic discrimination. Over the last seven decades, The Arc has played a significant role in supporting movement aimed to challenge these norms and advocate for equal rights and opportunities for individuals with intellectual and developmental disabilities.

As a grassroots organization, The Arc of Warren County has played a vital role in advocating for disability rights on a local, state, and federal level. The passing of the Americans with Disabilities Act (ADA) on July 26, 1990, was a pivotal moment in the disability

rights movement. The ADA prohibits discrimination against people with disabilities in various aspects of life, including employment, transportation, and public services. Since then, the disability rights movement has grown to include international awareness and events throughout the year, including Disability Pride Month in July.

In 2023, Disability Pride Month was officially recognized by New Jersey Governor Phil Murphy as a state-recognized month of awareness. During the month of July, the Agency recognizes the remarkable accomplishments of individuals who have triumphed over obstacles and shattered stereotypes. By celebrating these achievements, Disability Pride Month encourages a shift in societal perceptions, emphasizing ability over limitation.

This July, we celebrated Disability Pride Month and used the power of social media to increase awareness about the importance of accessibility and inclusivity. From advocating for accessible infrastructure to fostering respectful language and attitudes, we hope to continue to break down the barriers that hinder the full participation of people with disabilities in all aspects of life.

As part of our celebration, we asked people about what Disability Pride means to them. In an interview with long-time resident and advocate with The Arc of Warren County, Jill Young, she shared what she is proud of and what disability pride means to her. Jill believes disability pride comes from "people helping others, like having good health care, good staffing in the group homes, family inclusion, and support."
