#### Letter from the Chief Executive Officer

We are still waiting to see the impact recent Medicaid cuts will have on people with intellectual and developmental disabilities in NJ. Medicaid is our primary source of revenue, which makes it possible for us to provide the many services that we offer in Warren County. Even without cuts, it has become increasingly difficult for provider agencies to maintain services.

To understand this all that we must do is look at our own personal lives. The cost of operating a household has increased sharply in recent years when considering the surge in prices for food, utilities and maintenance, not to mention paying for rent or a mortgage. For The Arc of Warren County that impact is multiplied as we operate seventeen residences, a day program, a retail store and Camp Warren, not to mention our administrative building and a fleet of over thirty vehicles! Combine this with rising insurance costs and employing over 200 employees and it becomes quite clear what we are up against.

Fortunately, The Arc of Warren County has been able to sustain and grow services for over 70 years despite the barriers. This is thanks to our amazing staff that have been able to maximize the return on available funding sources, and our community, both individuals and business partners, who have so generously supported us financially. These people and businesses have been filling the gap since the beginning.

We are determined for The Arc of Warren County to have a great future providing outstanding services to people with intellectual and developmental disabilities. We will continue to advocate for more resources from state and federal entities and seek out grants and other sources of revenue. So, what can you do? Why not join us in securing the future of The Arc of Warren County?

We are asking everyone who values what we do and believes in our Mission to consider a bequest through your will or estate. This is a way to ensure that in the future our agency is strong and that our most vulnerable members of society get the best services possible.

## Jill Notte's Annual Membership Honors Sister's Legacy:

I will always feel a strong connection to The Arc of Warren County. The rare disorder from which my sister Gail suffered is called Prader-Willi Syndrome (PWS), and it has distinct challenges that make most group homes unworkable. The Agency was willing to take on these challenges and open a specialized group home for PWS in the 1990s. It became known as Hampton Terrace, and Gail lived there for more than 20 years.

At every level of the organization, the staff of The Arc of Warren County are caring and dedicated to their consumers. But the support and relationships go far deeper than that. I witnessed how staff and consumers become family members to each other. The Arc left no stone unturned to find solutions to the many challenges that arose across the days and years and

decades that Gail was in their care.

They enriched her life not only with activities but also with love and compassion that I know Gail could feel.

Gail passed away nearly four years ago, but I continue to be a member of the Agency and support it financially. I want to make sure they always have the resources they need to help Gail's precious housemates and all the friends she had in the community. My entire family will always be thankful for The Arc.

Before she became employed by The Arc of Warren County, she was a group home manager at Center for Humanistic Change. She then came on board 24 years ago as a job coach. She held many other positions, such as an employment specialist, a day program coordinator, a receptionist, an office manager and a clerk for Early Intervention.

Erin had the opportunity to work with Bonnie Hill who was her predecessor and mentor.

"Bonnie is very special to me," says Erin. "I loved working with her a lot. She was an inspiration to me and through her I became very passionate about this position. This work is very important to me."

In this position, Erin oversees and is responsible for project management of maintenance related opportunities for the Agency's facilities and fleet. This includes working with vendors and securing quotes for many projects. It includes upgrades and maintenance related projects for the Administrative Office, Serendipity, The Hive by The

Arc of Warren County, all the seventeen group homes and Camp Warren. She oversees a staff of three.

"It is a very busy department, and it is very fulfilling working with all of the different managers and coordinators and getting tasks completed," says Erin.

In Erin's spare time, she enjoys cuddling her cow (yes, you heard me correctly) and other farm animals, such as her goats, horse, chicken, ducks, geese and turkeys. Her favorite animal is Carl, her bull calf. Erin and her

husband own a farm in Knowlton Township called Treez N' Quackerz, which is located right around the corner from Camp Warren! Everyday Erin gets up at 4 a.m., including the weekends, to tend to her animals. She sells honey, eggs, jams and pickles, and her products are delicious.

## The Arc of Warren County's 35th Annual Radiothon with WRNJ Raises Close to \$83,000!

It is the longest running Radiothon in the state of New Jersey and one of the longest in all the United States. From 9 a.m. to 5 p.m., on May 1, 2025, WRNJ devoted the whole day to sharing stories about the impact of The Arc of Warren County's work from many different perspectives, including families, consumers, community leaders, board members and employees.

The 2025 Radiothon was co-chaired by Jim Travis, of Otterstedt Insurance Agency, and Norman Worth, of WRNJ, for the seventh consecutive year. Both Travis and Worth have advocated for the organization and individuals with intellectual and developmental disabilities for over 35 years. Travis serves on the Board of Directors for The Arc of Warren County. Both Travis and Worth are long-time members of the Hackettstown Rotary

Club and serve on the Advisory Board for Atlantic Health's Hackettstown Medical Center.

#### Generating Peace of Mind

The Arc of Warren County awarded a \$22,500 grant from The John A. & Margaret Post Foundation.

The Arc of Warren County has recently been awarded a grant in the sum of \$22,500 from The John A. & Margaret Post Foundation. These funds are earmarked for the cost of a power generator at one of the Agency's group homes in Greenwich Township and a generator at The Arc of Warren County's Camp Warren location.

This grant award has a substantially positive impact on the daily operations of the Agency, and ensures the safety and continuum of service for our campers.

On average, the Agency needs to relocate residents one to three times per year in the group homes that do not

have a power generator. This is because thunderstorms and snowstorms routinely cause a loss of power in the rural areas of Warren County.

The State of New Jersey mandates that relocation is necessary in extreme cold or hot temperatures in group homes. This has caused travel for the most vulnerable of The Arc of Warren County's residents in treacherous weather and road conditions causing serious hardship for the Agency. As a result of the limited hotel options in the immediate area, sometimes staff and residents have to temporarily relocate up to 20 to 30 miles away from their homes.

#### (Cont.) Generating Peace of Mind

The John A. & Margaret Post Foundation has funded multiple generators for The Arc of Warren County since 2019.

"The continued support that The John A. & Margaret Post Foundation provides has been extremely beneficial to The Arc of Warren County and those we serve," says John Whitehead, CEO of The Arc of Warren County. "In

addition, many of our residents find it very frightening and disruptive when they need to relocate due to power loss, even if it is for a short period of time. These generators make it possible for us to save on relocation expenses so we can spend our limited resources on other routine costs associated with operating residential programs."

### Jeffrey H. Hill Group Home Dedication of Newly Renovated Jonestown Road Home

On June 11, 2025, the Jonestown Road Group Home was renamed the Jeffrey H. Hill Group Home after his memory. Jeff Hill was the owner of J. Hill Carpentry and Construction and had a longtime affinity to the organization, overseeing many construction projects throughout the years. He did not just complete the project and do so in a high quality manner, he would complete it with love and care.

It was very fitting to specifically name the Jonestown Road home in his memory because J. Hill Carpentry was the company that completed a renovation of this home shortly before his death in September 2024.

Speakers at the dedication included John Whitehead and two of Jeff's children – Jairison and Kimberlee.

Attendees had the opportunity to share

favorite memories of Mr. Hill. An unveiling of the sign of this home was also conducted. His memory will continue to live on and he will be forever missed by his friends at The Arc of Warren County.
